Additional remarks by the Relationship Manager on beneficiary[1]	Yohan Gaikwad, renamed as Sandesh Gaikad, was found in good health. He was 9 months old as on verification visit date. He has been enrolled in the clinic (Dhobi Ghat Center of FMCH) since June 2015. The name of his mother is Kanchan Sandesh Gaikwad (Mob. 8082477483). Sandesh has been receiving nutritional guidance and calcium and protein supplements from the clinic. He visits the clinic twice a month.
Details of the beneficiary[2]	Soham More
Verification Visit status of beneficiary[2]	Success
Additional remarks by the Relationship Manager on beneficiary[2]	Soham More was found in good health on VV date. He completed 1 year on 1st April 2016 and has been going to the clinic (Ghobi Ghat center of FMCH) since birth. The name of his mother is Rohini Sunil More. He visits the clinic once a month. He is given calcium drops from the centre. His mother also receives some supplements for FMCH clinic.
Details of the beneficiary[3]	Expecting and new mothers with their young children
Verification Visit status of beneficiary[3]	Success

Additional remarks by the Relationship Manager on beneficiary[3]	The FMCH clinic at Dhobi Ghat has one nurse and one nutritionist. The name of the nurse is Shravni Parab and the name of the nutritionist is Shalini Daman. Shalini Daman was on leave on VV day. Hence we called her up and asked the requires details. She will be completing 2 years in FMCH in May 2016. She is receiving INR 20000 per month as salary in the bank account. In addition she receives INR 500 as compensation for mobile bills. FMCH takes a nominal amount of INR 100 only once when the child is registered in the clinic.
